BLUE BIRD INN - PARKING LOT CONDTIONAL APPROVAL

Raymond Fratini made the motion, seconded by John Karinch to give Conditional Approval of the LDP with the Five Waivers recommended by Hanover Engineering, pending resolution of the eight stormwater management comments listed in Hanover Engineer's September 2nd letter, provision financial security and pending approval of the PennDOT Highway Occupancy permit application for the parking lot exit driveway. The recording of revised deeds for the Five (5) lots and access easements for Lots 1 and 4 is also required. Motion passed.
